ACSI *Inspire* Update

We are pleased to announce the publication of the final version of the [ACSI *Inspire* Manual!](#) During the spring of 2023, seventeen schools hosted a pilot visit using the *Inspire* protocol. ACSI gathered feedback from pilot schools, chairs, and team members, as well as input from others. Many of the comments were positive and affirmed the collaborative and reflective nature of the process, as well as

***Inspire* Addendums**

Along with the *Inspire* protocol, we have published a number of addendums covering EE programs, online schools, hybrid schools, International Student Programs (ISP), and Residential programs. You can find the addendums on our [website](#). Each addendum provides information on when a school must utilize that addendum in conjunction with the *Inspire* protocol. For

the focus on school improvement. There was also some very helpful feedback that enabled us to refine the *Inspire* protocol and process. Here are a few of the changes we made based on the feedback:

- Adjusted indicator wording for clarity, including separating a few indicators to differentiate between concepts
- Added indicators addressing succession planning and leadership development
- Removed the Reflective Questions from the Self-Study
- Streamlined the Survey and Assessment response requirements within the self-study (each of these sections has been reduced to three broad questions, allowing schools to articulate their process for administration, analysis, and application)
- Provided clarity in the Chair and Team handbook for the visiting team's written responses, the Collaborative Goals Meeting, and the Accreditation Action Items

These changes will serve to strengthen and streamline the *Inspire* protocol for schools moving forward.

ACSI *Inspire* Training

schools with an ISP program or Residential program, the requirement to utilize the ISP addendum and/or the Residential addendum will go into effect with visits starting during the fall of 2025. Each addendum provides thresholds indicating when the addendum is required.

Please note: Use of an ACSI alternate accreditation protocol, endorsement protocol, or addendum may require ACSI to add visiting team members with specialized training, knowledge, or experience that would need to travel from a greater distance than team members on a typical visiting team. Reasonable travel expenses would need to be accounted for accordingly and reimbursed by the school.

Annual Reports

The annual report process for ACSI accreditation will remain much the same this year. Contact your [Divisional Accreditation Team](#) for details. However, look for some significant changes to the annual reporting process next year due to the implementation of a new Certification system, as well as a new Accreditation system.

CEU Conversion Change

- ACSI's CEU conversion rate has changed from 6 clock hours = 1 CEU to 1 clock hour = 1 CEU. This will better align with standard practice from various other continuing education providers.
- The number of Bible CEUs needed to gain the Standard and Professional level certificates has been decreased, although with the 1:1 conversion change, it may look like more! .
