Acceptance of the Terms of Use

These terms of use are entered into by and between You and Association of Christian Schools International ("**ACSI**", "**we**" or "**us**"). The following terms and conditions, together with any documents they expressly incorporate by reference ("**Terms of Use**"), govern your access to and use of <u>www.acsi.org</u> and community.acsi.org (the "**Website**"), including any content, functionality and services offered on or through **Website**, whether as a guest or a registered user.

Please read the Terms of Use carefully before you start to use the Website. By using the Website, you accept and agree to be bound and abide by these Terms of Use[and our Privacy Policy, incorporated herein by reference. If you do not want to agree to these Terms of Use or the Privacy Policy, you must not access or use the Website.
